Sealed bids are invited from eligible and experienced contractors/agencies for the Land Leveling with RCC Pillar Demarcation Work as per the following scope:

### Scope of Work

# The Approx. Land Area is 3 Hectare.

1. Land Leveling: The site currently has large mounds and uneven terrain ("soil mountains"). It is to be leveled to prepare the area for future construction and development.

2. Boundary Demarcation: After leveling, boundaries must be marked using RCC (Reinforced Cement



Concrete) pillars. Barbed wire fencing is to be installed along all sides for security and clear demarcation.

#### Terms and Conditions

1. Experience:

The bidder must have a minimum of 3 years of experience in land leveling with RCC pillar demarcation work. Copies of relevant work orders and same work experience certificates must be self-attested and submitted.

2. Financial Turnover:

The bidder should have an average annual turnover of ₹10 Lakhs during the last three financial years (2021-22, 2022-23, and 2023-24). Proof must include:

- o Audited Balance Sheets with UDIN generated and signatures from authorized signatories.
- Profit & Loss Statements
- Income Tax Returns

3. PAN/CIN:

A copy of the PAN or CIN number of the company/firm must be attached.

4. Local Office Infrastructure:

A self-certified declaration stating the presence of a fully-fledged office in the buyer's local area(Lucknow) must be submitted.

5. Service Support:
